1.1) Police Department Quarterly Report: B. Lee: Chief Lee reported on the Police Department's various projects, such as Lenslock, modifying current car designs, training, and transitioning dispatch to the Marble Falls Communications Center. Per Chief Lee and Chief Ingram, the dispatch transition has been relatively smooth, and all is going well. Additionally, Chief Lee reported that the SRO Program is being revamped and eventually, BCISD will take over the program and meet statutory requirements.
