5.1) Finance Monthly Report: P. Langford: Patricia Langford, Finance Director, reported on the financial status of several departments within the City. Mrs. Langford stated that many departments are doing well, specifically the utility department and airport, as well as the golf course. The utility department has seen an increase in water sales, while the airport has had an increase in jet fuel sales. The “unrestricted” cash balance over 90-day reserve has a balance of \$1,065,163


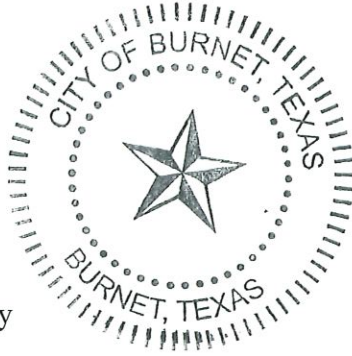
