

RESOLUTION NO. R2023-34

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BURNET, TX., CANVASSING THE ELECTION RETURNS AND DECLARING ELECTION RESULTS IN THE GENERAL ELECTION AND SPECIAL ELECTION HELD IN THE CITY OF BURNET, BURNET COUNTY, TEXAS, ON MAY 6, 2023, FOR THE PURPOSE OF ELECTING ONE MAYOR AND THREE COUNCIL MEMBERS; AND FOR THE PURPOSE OF SUBMITTING FOR APPROVAL OR REJECTION; A PROPOSAL TO AUTHORIZE THE SALE OF CITY PARKLAND PROPERTY

WHEREAS, under and by virtue of Resolution 2023-11; duly passed by the City Council of the City of Burnet, Texas, on January 24, 2023, and thereafter published in accordance with the law, and election (the General Election) was held in said City on May 6, 2023 for the purpose of electing one mayor and three council members, and

WHEREAS, under the virtue of Ordinance 2023-03; duly passed by the City Council of the City of Burnet, Texas, on January 24, 2023, and thereafter published in accordance with the law, a special election was held in in said City on May 6, 2023, for the purpose of submitting for approval or rejection; a proposal to authorize the sale of city parkland property; and

WHEREAS, the City Council has investigated all matters pertaining to the general and special election and has determined that notice of said general and special election was actually given as required by law, and said election was duly and legally held on May 6, 2023, in conformity with the election laws of the State of Texas, the City Charter and the Voting Rights Act of 1965, and the results of said general and special election has been certified and returned to the City Council by the proper judges and clerks thereof; and

WHEREAS, the City Council has today considered the returns of the general election held on May 6, 2023, for the office of Mayor and three Council Members elected at-large, and for the approval or rejection of the proposition as appearing from said returns, duly and legally made, that there were cast at said election 667 valid and legal votes as set forth below; and

CITY OF BURNET PROPOSITION A

Shall the City be authorized to sell property as described below; under the provisions of Section 253.001(b) of the Texas Local Government Code:

FOR 198

AGAINST 83

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BURNET, TEXAS, THAT:

Section 1. The City Council officially finds, determines, and declares that the elections were duly and properly ordered, that proper legal notice of such elections was duly given in the English language and the Spanish Language, that proper election officers were duly appointed prior to the elections, that the elections were duly and legally held, that all resident, qualified electors of the City were permitted to vote at the elections and due returns of the results of the elections has been made and delivered, and that the City of Burnet has duly canvassed such returns, all in accordance with the laws of the State of Texas and of the United States of America and the Resolution R2023-11 and Ordinance 2023-03 calling the elections.

Section 2. The General Election was duly called; that notice of said General Election was given in accordance with law; and GARY WIDEMAN running unopposed, was duly elected as Mayor for a term of two years and RICKY LANGLEY, TRES CLINTON, and JOYCE LAUDENSCHLAGER were duly elected Council Members for a term of two years. Each of the said above named parties are hereby declared duly elected to said office, subject to the taking of their oaths of office as provided by the laws of the State of Texas and the City of Burnet, Texas.


Section 3. The Special Election was duly called; that notice of said Special Election was given in accordance with law; for Proposition A, that the City be authorized to sell property as described as Highland Oaks Public Park located in the Highland Oaks Subdivision and particularly described as: all of the approximately 1.3902-acre lot described as Highland Oaks Subdivision Phase One (1) Lot No. Three (3), Block No. Nine (9), Burnet County, Texas as shown on the Plat recorded on March 27, 2003, as Instrument No. 200303659 in the Public Records of Burnet County, Texas; and all of the approximately 0.6779-acre lot described as Highland Oaks Subdivision Phase Two (2) Lot No. Thirty (30), Block No. Six (6), Burnet County, Texas as shown on the Plat recorded on March 27, 2003, as Instrument No. 200303659 in the Public Records of Burnet County, Texas; under the provisions of Section 253.001(b) of the Texas Local Government Code; with a total of 198 votes in favor and 83 votes against.

Section 4. It is hereby officially found and determined that the recitals contained in the preface of this resolution are the true and correct legislative findings of City Council and such findings are incorporated into this resolution for all purposes.


Section 5. It is hereby officially found and determined that the meeting at which this resolution is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, *Chapt. §551, Tex. Gov't. Code*, having been posted and remaining posted continuously for at least 72 hours preceding the date of this meeting.
